NATIONAL TUBERCULOSIS ELIMINATION PROGRAM (NTEP)

APPEAL TO ALL ESTEEMED MEMBERS OF ALLAHABAD MEDICAL ASSOCIATION / PRIVATE PRACTITIONERS / FACILITIES

In 2018, the Prime Minister of India envisioned ending TB in India by 2025, five years ahead of the global Sustainable Development Goal (SDG) target of 2030. More than 50% of TB patients access the private sector for diagnosis, treatment and prevention. One of the key elements for TB elimination is TB notification. TB notification is not merely to capture numbers, but is also important to provide patient-centric, family focused public health actions, often an implementation challenge for many private practitioners. Under the National TB Elimination Program, ALL TB patients are offered free diagnosis, treatment with fixed dose combination (FDC) drugs, and a direct benefit transfer (DBT) of Rs 500/- per month for the duration of treatment to support nutrition. The State of Uttar Pradesh has engaged with Patient Provider Support Agencies (PPSA) to support private practitioners with notification, specimen transportation for microbiological confirmation and patient/family counselling for treatment adherence support. In 2022, Private sector TB notification at Prayagraj is a mere 64% of the target, while the public sector notification is at 98%.

The Allahabad Medical Association (Branch of IMA) appeals to all its members to:

- Notify all TB patients diagnosed or initiated on treatment in your clinic/health facility.

Coordinate with the PPSA staff and district TB officials to update patient information to enable them to access government free services (Universal Drug Sensitivity Testing using TRUENAT/CBNAAT, free FDC) and schemes (DBT) and to provide them with counselling
