From the Desk of Hony. Secretary

Report of meeting of Executive Committee held on 22nd July, 2020

Several important issues were discussed at the executive committee meeting and following is a report on some important issues raised and decisions taken.

- In response to certain false allegations being raised on social media groups created in name of AMA, it was categorically stated that NO member of executive or any member on any committee permanent or temporary, has ever drawn any salary from AMA. Members condemned the false and mischievous propaganda being spread by some members on social groups with intention of spoiling the reputation of its members by labeling false accusations. It was also pointed out that members of the executive committee are the first to get registered for AMA activities like CMEs and cultural events and only those registered take part in the events. This false propaganda was also condemned by members who insisted that strict action should be taken against members making false accusations.
- It was pointed out that the land where AMA Blood Bank is situated was built was donated by Sri.M.L.Ahuja largely due to the efforts of Dr.A.K.Ghosh who was President, AMA at that time.
- Several members noted that as per reports three parallel blood banks are going to start soon in the city and at least one will have members of AMA/ Nursing Home Association as active participants. It was felt this is likely to lead to conflict of interest. Active efforts are also being made to lure away staff from AMA Blood Bank with offers of increased salaries. Several members expressed the fear that attempts are being made to sabotage AMA blood bank which is the pride of AMA and IMA UP State by vested interests.
- Motion condemning false, abusive and malicious accusations on some social groups against elected members of executive committee was passed unanimously.
- Younger members led by the Scientific Secretary Dr.Ashutosh
 Gupt requested executive committee to protect elected
 members from malicious and politically motivated propaganda
 otherwise no one will agree to work for AMA in future.
- Dr. Ashutosh Gupta, Scientific Secretary in formed in great detail efforts of AMA for fighting the pandemic. (Detailed report is given by Dr.Ashutosh Gupta in this newsletter)
- Dr. Yuganter Pandey informed about the financial position of AMA (Detailed report is given by Dr. Yuganter Pandey in this newsletter)
- The executive discussed in detail the letter issued to one of its members Dr.Ashok Tahiliani for leveling false and malicious charges against office bearers and took on record the letter written by Dr. Ashok Tahilaini. The matter was referred to the disciplinary committee for necessary action.

Report of Scientific Secretary Dr. Ashutosh Gupta

Regarding Covid Related Activities.



We started searching for a designated Covid centre, as and when COVID cases started rising in our city, about 2 months back with the help of Dr. Sujeet Singh, Dr. Neeraj Agrawal, Dr. J.V. Rai, Dr. Yuganter Pandey, Dr. Rajeev Singh, Dr. Siddharth Madnani and Dr. Rajeev Srivastava. Initially we thought for running hospital for L1 & L2 setup according to guidelines and discussions with authorities. We met with management of United Medicity and Narayani Ashram Hospital as they are situated outside dense population but management of both hospitals was very reluctant for Covid hospital.

We searched and visited many places around the city including Global Medicare Naini, Intermediate College, Nani, Private Homeopathic Medical College, Bamrauli, Nazreth Hospital, Engineering College, Bamrauli, Agricultural Institute Hospital, Naini, up coming para medical institute and hospital, but things did not materialize. We discussed with administration regarding setting up of Covid centre at AMACC, but this was ruled out by administration on the following grounds:

- 1. It is situated in populated area, shares common boundaries with house belonging to sitting MP, Police Lines with VVIP Helipad, house of eminent criminal lawyer, hotel and shop, and is also situated near two busy hospitals.
- Road in front of AMACC is a National Highway and cannot be blocked as is often required for Covid hospitals.
- 3. It has three large halls with one set of toilets on each floor only.
- 4. Centrally Air conditioned so risk of infection transmission inside will be very high.
- 5. AMACC was not built for the purpose of the hospital and it is not possible for it to be converted into the hospital which is a basic requirement for any Covid hospital.
- Administration insisted on creating L2 and L3 facilities in existing hospital with ICU
 setup and was not interested in proposal for setting up only L1 facility. They informed
 that Home Isolation is going to be allowed soon so only L1 facility was not feasible.

Dr. Ashok Agrawal, Dr. Radharani Ghosh, Dr. Neeraj Agrawal, Dr. Rajeev Singh, and Dr. Ashutosh Gupta held meeting with DM again regarding designated Covid centre for L1 facility, but authorities insisted on starting only L2 / L3 facility in Private sector. The human resource requirement, finances etc were discussed and calculated in a meeting with Dr. J.V. Rai, Dr. Avaneesh Saxena, Dr. Sujeet Singh, Dr. Niraj Agrawal, Dr. Rajeev Singh and Dr. Yuganter Pandey. It was found that approximate monthly expenses will come to around 40 to 50 lakhs per month including catering with food, lodging in same facility and salary for L1 Centre. Additional funds would be required for converting existing facility to Covid Cente as per government specified norms. The government policies also kept changing. Main constraint was arrangement of staffs, for which SMS was sent to all respected members of AMA for volunteers in proposed Covid centre (on payment) but very few responded.

However, in this context the latest news is that thanks to the intense efforts of many AMA members actively in the project, an L1, L2, Covid centre under AMA with special facilities for AMA members is likely to come up soon, providing the best possible care. Honourable members will be informed about it by SMS soon and details will be placed on AMA website.

CMEs:

- Several CMEs were arranged on Infection Prevention Control for COVID-19 in association with CMO Office for our respected members.
- An online evening CME on the topic of Asthma/COPD by Dr. Ashutosh Gupta and Dr. A.K.
 Singh was held on 15 June at 6:00 pm. Topic was very well covered by both the Speaker.
- Doctor's Day was celebrated through online platform at AMACC on 1st July at 8:00 am.
 Our Corona warriors got felicitated on that auspicious day.
- Webinar on COVID-19 was arranged by AMA for its members on 1st July at 6:00 pm.
 Topic was very well covered by Prof. J.C. Suri Sir (Director JCS Institute of Pulmonary Critical Care and Sleep Medicine and Director Pulmonary Medicine, Fortis Hispital).
- Online evening CME on the topic of Vertigo management was held on 15 July at 6:00 pm. lecture was very well covered by Dr. Gulab Soni, a famous neurologist of our city.

Provisional report of Finance Secretary Dr. Yuganter Pandey presented before AMA Executive committee meeting held on 22nd July, 2020



- Dr.Yuganter Pandey informed the executive that AMA had taken one loan of 11 cores for construction of AMACC, out of which Rs 6,27,88291 is still remaining to be repaid. Other major payment which is still pending is about Rs 1.25 crore to be given to Chisel company for the AMACC work completetion which includes additional work done at AMA Blood Bank. This will have to be paid as soon as they submit all the relevant bills and documents.
- amA has FDs totaling Rs 78.83 lakhs mainly from the amount deposited by members as AMA CLUB membership fee, life membership fee and orations corpus funds.
 - $AMA has \ Rs \, 93 \, lacs \, in \, saving \, account \, in \, SBI \, and \, approximately \, Rs \, 1.12 \, crore \, in \, current \, accounts \, totaling \, Rs \, 2.05 \, crores \, in \, bank \, accounts.$
- AMA has to pay approximately Rs. 21 lacs as EMI for the bank loan (every month).
- In the last financial year AMACC received Rs.43,36,897/= as rental charges and approximately Rs.26,88,100/= through contract done with the caterer .After deducting regular expenses (minus EMI which was paid by internal loan from AMA Blood Bank funds) AMACC earned profit of Rs. 22,15,335/=
- It is expected that the loan will be fully repaid by the year 2024.
- The fixed monthly expenditure of AMA is about Rs 42 lacs under the heads of staff salary, bank EMI (as above), energy bills, security charges, etc
- Till date we have not missed even a single EMI and even in these difficult Corona times, AMA is able to pay all dues. However, AMA should not take any new responsibility.

 The Finance Secretary brought to the notice of the house that as per reports three more blood banks are coming in our city very soon and one of them will be run directly or indirectly by Doctors who are also members of AMA/ Nursing Home Association. AMA should keep this fact in mind and be very vigilant in making future plans as these blood banks may have significant impact on AMA.

Experience of Dr. S. Nazim, MD, As corona patient



Let me introduce myself...I am Dr. S.Nazim. MD Medicine from our MLN MEDICAL COLLEGE ALLAHABAD, retired from PMHS, Uttar Pradesh in April 2017, luckily at 60 years age from Colvin Hospital, Allahabad and later started medical practice in Allahabad mostly in Kareli area. After Covid pandemic declaration, I stopped practice for almost three months and later resumed it to few Diabetes and hypertension patients, some of them might have concealed the history of flu like illness.

It is my experience as Corona patient admitted on 6th July 2020 evening at SRN hospital Allahabad and discharged on 16th July 2020. Actually I started running moderate fever from 28 June 2020 night and after 5 days I developed cough. I called Dr D.K. Agarwal, renowned cardiologist and my senior who immediately advised CT Chest. I rushed to Kriti scanning where CT Chest revealed Covid like features following which Dr DK Agarwal referred me to SRN hospital urgently with one of his medical

attendant. While on way to SRN, I got many telephonic calls from my medical colleagues juniors and seniors. First was from Dr.Anubha, Dr Sarita Bajaj and Dr. SP Misra. They immediately arranged my hospitalization directly in ward 2 and I was immediately given 4 liters of Oxygen. Subsequently, 10L of Oxygen was for five days in Ward 8 and withdrawn gradually. So big was the list of my calling doctor friends, that it is difficult to name them. My batchmates were equally concerned. Dr Sujeet Singh Surgeon, a loving junior friend of mine immediately informed Dr Mohit Jain and Dr.Ajit Chaurasia who reached at their earliest. Meanwhile my blood test and Covid samples were taken within 1 hour. After some stability I was shifted to Ward 8. Principal Dr S.P. Singh, Dr Arun Srivastav, and Dr.Shabi Ahmad HOD surgery also rang me up several times to encourage and assured their full support. Regular and constant monitoring was being done at their best. Some suggested that I rush to SGPGI but bed was not available there. I soon realized that here I was a VIP but outside Allahabad, I would just be a routine and common patient. Positive attitude of my attending doctors was excellent. Dr Mohit Jain, (although a plastic surgeon) is the Corona in charge at SRN and deserves special mention for his humble presentation and positive approach. Apart from the routine time of visit of consultants, the young residents had many extra hours of visits. Many used to visit past midnight. In their white glistening PPE kits, they used to appear like "FARISHTE" (devdoots) to our rescue. Their dedication was hard to believe. Meals with good quality food material were frequently served in most hygienic manner in unrestricted amount. Remarkable aspect of my stay was the level of cleanliness maintained at all times, making comparable to the best in private setup. I am now in my home with excellent recovery. All praises and thanks are for my ALLAH. But HIS "bande" deserve the appreciation very much. When I bow myself before my ALLAH, my heart and soul salutes these untiring, high risk taking colleagues from my medical fraternity. I am not able to name all of them here but it is due to their efforts that I was discharged on July 20. I shall never forget the love, care and affection I received while in the hospital.
